

FRONT OF RAD GUARD





FITTING INSTRUCTIONS

- To fit R&G radiator guard to the bike, insert the 7x rubber grommets into the radiator guards in the holes circled in green in the **Fitting Diagrams** above.
- Remove the bolts and plastic panel circled in red in Picture 3.

Upper Rad Guard Fitment:

Offer the R&G Radiator Guard into position, wedging the top tab (circled yellow in **Picture 2**)
between the plastic shroud and radiator, then insert the original bolts back through the two
mounting holes where the plastic panel was removed from.

Lower Rad Guard Fitment:

Offer the R&G Radiator Guard into position, wedging the bottom tab (circled in yellow in **Picture 3**)
between the plastic shroud and radiator, then insert the original bolts back through the two
mounting holes.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
